- The successful firm will be required to deploy the personnel <u>1st July 2017</u>. The contract shall be for the period from <u>01-07-2017 to 30-06-2018</u>. The contract can be extended for a further one year, subject to functional requirements.
- 2. The successful bidder will be expected to comply with relevant regulations especially in the matters of pay, allowances and other benefits as notified from time to time by the Govt. The registered agency shall be independent one and shall be in complete charge of the men engaged in performance of the works and shall perform the works in accordance with law of land and at his own risk.
- 3. No labour <u>below the age of eighteen years</u> shall be employed on the work and an explicit certificate to that effect shall be provided.
- 4. - 6. The agency shall pay to the labourer if employed by him wages not less than the fair wages and shall comply with the provisions of Payment of Wages Act 1936, Minimum Wages Act 1948, Employees Liability Act 1938, Workmen's Compensation Act 1923, Industrial Disputes Act 1947, Maternity Benefits Act 1961 and Contractor's Labour (Regulation & Abolition) Act 1970 or the modification there of or any other laws relating thereto and the rules made there under from time to time.
- 7. The Agency shall <u>ensure that all mandatory deposits on account of EPF and ESI etc., as</u> <u>stipulated are made and the worker is paid the wages on the due date.</u> The agency will be expected to furnish supporting documents in this regard failing which no payments shall be released.

- 8. During the performance of the works the Agency shall at his own cost and initiative fully comply with all applicable laws of the land and with any and all applicable By-laws, Rules, Regulations and orders and any other provisions having the force of law made or promulgated or deemed to be made or promulgated by the Government, Government-agency or relevant Municipal body or other regulatory or authorized body of persons and shall provide all certificates of compliance therewith as may be required by such applicable Law, By-Laws, Rules, Regulations orders and/or provisions.
- 9. If the work of the staff deployed by the company is found to be unsatisfactory, the Director, MSME-DI, New Delhi will be at liberty to entrust the same to any other firm at the risk and expense of the defaulting company. In this connection, the decision of the Director, MSME-DI, New Delhi shall be final and binding upon the Company/agency.

The deployment will be for 8 hour shifts per day and Extra duties if any performed by the personnel due to exigencies of work will have to be indicated separately on pro rata basis as per actual extra duties. Payment will be made to the contractor monthly basis. <u>All Payments will be made only by mode of digital Payment/RTGS</u>
